Applications for filling up the post of Managing Director, Indian Ports Association

The Indian Ports Association (IPA) invites applications in the prescribed format (attached) from eligible persons for the post of Managing Director of IPA in the pay scale of Rs.1,80,000-3,20,000 (industrial DA pattern).

- 2. IPA is a Society registered in Delhi under the Societies Registration Act, 1860. IPA works as mutual benefit organisation serving all major ports; Ministry of Ports, Shipping and Waterways and other stakeholders of ports and shipping sector, for improvement and modernisation of maritime transport.
- 3. The Managing Director (MD) of Indian Ports Association is the Chief Executive of the Organization and is responsible for all aspects of IPA. He is required to exercise administrative, disciplinary and financial control on all activities and also to supervise the functioning of various verticals of IPA.
- 4. The appointment to the post of MD may be made on deputation or contract basis. The deputation will be for a period of 3 years, which is extendable up to 5 years. The contract will be for a period of 2 years, which is extendable up to 5 years or as may be decided by the appointing authority.
- 5.(i) In case the post is filled up on contract basis and the incumbent is a retired officer from Government/Major Ports or Public Sector Undertakings etc., the consolidated remuneration will be his last pay drawn minus pension per month. In addition, he will be provided with official vehicle for official purposes and furnished leased accommodation or house rent allowance in lieu thereof at the rate of Rs.50,000/- (Fifty thousand rupees only) per month.
- (ii) The CTC for the candidates selected from other than Govt./Major Ports/Autonomous Bodies/PSUs shall be Rs.50 lakhs per annum.
- 6. **A.** Eligibility criteria for deputation

 For officers working in Major Ports or Autonomous Bodies, Public Sector Undertakings:

Having the experience of the post of Chairperson or equivalent

OR

Having the experience of the post of Deputy Chairperson or equivalent for at least 2 years

OR

Having the experience of the post of Head of Department (Traffic, Personnel & Administration, Finance, Marine and Engineering) on regular basis for at least 10 years

B. For AIS/Central Civil Service Group 'A' officers:

Officers belonging to All India Services /Central Civil Services Group 'A' who have put in not less than 16 years' of service in Group 'A' out of which at least 10 years must have been spent in port planning/operation/administration etc. in Port and Shipping sector.

- i. Educational Qualifications Postgraduate in any discipline
- ii. Professional experience

25 years' executive experience out of which at least 5 years shall be as Head of a core functional area in port/maritime sector.

OR

Having the experience of Chairperson or equivalent in a major port;

OR

Having the experience of Deputy Chairperson or equivalent for at least 2 years in a major port.

OR

Having the experience of Head of Department (Traffic, Personnel & Administration, Finance, Marine and Engineering) on regular basis for at least 10 years in a major port;

OR

Has been an officer belonging to All India Services /Central Civil Services Group 'A' who has put in not less than 16 years' of service in Group 'A' out of which at least 10 years must have been spent in port planning/operation/administration etc. in port and shipping sector.

- 8. The maximum age limit to apply for deputation basis is upto 57 years and in case of contract basis is upto 62 years on the last date for receipt of applications.
- 9. Applications of serving candidates shall be considered on deputation basis, if he/she wishes to keep lien in his/her parent organisation.
- 10. While forwarding the applications of the eligible serving candidates the concerned authorities may ensure that the following documents are forwarded with the application form:
 - a. Attested copies of APAR of the last 5 years.
 - b. The Vigilance status of the candidate
