

## CIRCULAR

## To, Lessees/ Tenants/Licencees and all concerned under Income Tax Act.

It is to note that the Income Tax Authorities have issued Exemption certificates u/s 197 of Income Tax Act.1961 r.w.s. 194A, 194C, 194IB and 194J ibid authorizing Port users, lessees and tenants and the banks/ financial institutions with TAN mentioned in the certificates to deduct tax at source at the lower rates as mentioned below:

- The certificates are valid for the period from 25.08.2023 to 31.03.2024. The certificates are conditional and the lower rate of TDS is applicable on the quantum of income mentioned in column 7 of the certificate. Thus, the parties whose names with TAN appear in the certificates have been authorized to deduct the tax at reduced rate allowed by Income Tax Authorities while making payment of various charges to MbPA as per provisions of Income Tax Act 1961. Further details may be obtained from Income Tax Department.
- Since the Application process of Lower Deduction certificate was online, the parties can now check their Limits as mentioned in the lower deduction certificate in their Traces site and the rate of tax as per the lower deduction certificate is also reflected on the parties' traces site.
- copies of certificates have also been posted on MbPA website  $(\underline{www.mumbaiport.gov.in}) \rightarrow Downloads \rightarrow Circulars \rightarrow Estate Circulars as "TDS Certificate" and$ displayed on the notice board near Cash Office of Estate Division for general information of Port Users and others. Kindly ensure that 0.35% Tax at source is deducted while making payment of rent/ compensation to MbPA as mentioned in Para 2 above. The certificates are valid till 31.03.2024.
