### MUMBAI PORT AUTHORITY

#### NOTIFICATION

No. FA/ACC/232(A)/2262.—In exercise of the power conferred under Sub-section (1) of Section 27 of the Major Port Authorities Act, 2021, the Board of Mumbai Port Authority *vide* Board Resolution No.100 has approved in its meeting dated 20th August 2024 the modification in existing SOR provision of Mumbai Port Authority at (i) Note (v) to table 3.3(A) II and 3.3(A) III and (ii) Note (e) to table 3.3(A)(V) I & 3.3(A)(V) II.

Accordingly, as required under Clause 4.7 of Tariff Policy, 2021, Board of Mumbai Port Authority hereby publishes modification in existing SOR provision of Mumbai Port Authority at (i) Note (v) to table 3.3(A) II & 3.3(A) III and (ii) Note (e) to table 3.3(A)(V) I & 3.3(A)(V) II for information of all concerned. As per clause 4.8 of Tariff Policy, 2021, amendment shall come into effect after expiry of 30 days from the date of Notification in the State *Gazette* by Major Port Authority.

A statement of existing notes of SOR *vis-à-vis* approved modifications as per BR No.100 dated 20th August 2024 is tabulated below :—

<p>“Unauthorised storage –</p> <p>In case of unauthorized / excess occupation of areas for storage, penal charges @ 2x Storage fees will be recovered from the date of unauthorized / excess occupation till vacation of such area or till regularizing of the unauthorized / excess storage. Also, as storage fees is recovered for per month or part thereof, such double storage fees for unauthorized / excess occupation will be applicable for whole month even if unauthorized / excess occupation is for a period of less than 30 days.”</p>	<p>“Unauthorised storage –</p> <p>In case of unauthorized / excess occupation of areas for storage, penal charges @ 2x storage fees will be recovered from the date of occupation of unauthorized / excess occupation for a period of 01 month. The 2x license will become 3x for the subsequent month (second month) and will continue to increase by 1x for every additional month of unauthorized usage till vacation of such area or till regularizing of the unauthorised / excess storage. Also, as storage fees is recovered for per month or part thereof, such enhanced storage fees for unauthorised / excess occupation will be applicable for whole month even if unauthorised / excess occupation is for a period of less than 30 days.”</p>
