1. This is issued Subject to Provisions of Dock Bye Law No. 130.

Motor lorries or other vehicle for the conveyance of goods shall not be driven along or upon any of the roads, wharves or quays within the Docks or be admitted into or allowed in the Docks unless a permit in that behalf shall have been procured from the Traffic Manager permitting such lorry or vehicle to do so except in accordance with the following rules and regulations.

- (i) Such motor vehicle shall confirm in all respects to the Mumbai Motor Vehicles Rules 1915 and Public Conveyance (Motor Vehicles) Rules 1922 and such variations of the same as may from time to time be in force.
- (ii) Such Motor vehicles shall not be left unattended.
- (iii) Such Motor Vehicles shall ordinarily transverse the recognized roads in the docks, but may be permitted on the wharves in transit sheds an upon open storage spaces for the purpose of being loaded and unloaded, subject to control by Port Trust and Police Officials.
- (iv) Such motor lorries or vehicles, when entering or leaving the docks, shall stop at the Docks Gate by which they are entering until permission to pass has been obtained from the Port Trust and/or customs officials on duty at the gate and the driver thereof shall on demand produce for inspection the license permitting the lorry or vehicle entry into Docks.
- (v) No such motor vehicles will be allowed to remain with the Docks longer that shall in the opinion of the Docks Manager, the necessary for the purpose of loading or unloading goods loitering and plying for hire is

prohibited.

- (vi) No such motor lorries will be permitted to charge their tanks with petrol or other fluid fuel within the Docks without the Docks without the special permit from the Traffic Manager, Subject to special permission being obtained, small quantities of petrol or other fluid fuel may be removed from cars awaiting shipment or filed into cars awaiting removal ex-Docks at paces named in the permits in the former case, such petrol or fluid must at once be removed from the Docks limits. The use of any metal screw stoppered container for conveying petrol into or our to the Docks is prohibited.
- (vii) No such motor vehicles shall be driven on East wharf, Princess Dock at speeds exceeding twelve miles per hour.
- (viii) No such motor vehicles shall be driven over any of the Dock entrance or communication bridges at speed exceeding six miles per hour, and shall not cross bridges when their axle weights are in excess of those shown on the respective notice boards erected at near to those bridge.

2. Charges
