1) A Resolution was passed by MbPT on 14.06.2013, vide No. 49, in the said Resolution 2 (two) Nos. Resolutions were passed. As per 1 <sup>st</sup> Resolution was to stop operating water supply facility at Lakri Bunder (North) by HWSCPL and 2 <sup>nd</sup> open bids be invited expeditiously for grant of at least two licenses for operating water supply facilities at Mumbai Port. Let me know, has any of the two resolutions passed as above been successfully fulfilled by MbPT till today or both resolutions are	1) The Plot admeasuring 1650 sq. mtrs. at Lakri Bunder North was taken over from M/s. HWSCPL on 01.07.2015.  Open bids were not invited by Traffic Department.

fulfilled till today and if it is fulfilled then I require details of them (means complete information) of the necessary action taken by MbPT on the above 2 resolutions.

2) Also any status report of HWSCPL was submitted by Bunders office and TM office with copies of the same and also any Termination letter to HWSCPL was issued by Traffic Manager, MbPT with its copy.

2) Status report vide letter No. TM/BDR/2233 dated 27.07.2015 was forwarded by Dy. Traffic Manager, Bunders (01 Page).

Letters Nos. TM/B/10A-01/4738 dated 06.07.2013 and TM/B/10A-01/2532 dated 30.05.2015 were issued to M/s. HWSCPL. (02 Pages).

Certified photocopies of the said letters are being readied to be supplied to you are of total 03 pages. The additional fee for supplying this information to you amounts to Rs. 06/-. [03 pages x Rs. 2 = Rs. 06.00].

You are therefore requested to pay Rs. 06/- at the office of Traffic Manager by Demand Draft/ Pay Order or Postal Order drawn in favour of 'The Board of Trustees of the Port of Mumbai' at the earliest. Upon receipt of the additional fee, the said documents will be provided to you.
