Sub:- Information sought under RTI Act, 2005.

Ref:- Your RTI application dated 09.01.2019.

Vide your RTI application dated 09.01.2019 you have sought information as (a) Copy of letter vide Inward No.1347 dtd.07.01.2019 and (b) Copy of letter vide Inward No.1347(A) dtd.07.01.2019.

2. The letter vide No. 1347 dated 07.01.2019 is letter written by Shri A.V. Baokar (third party) about resuming on duty and letter vide No.1347(A) dated 07.01.2019 is copy of order passed by Appellate Authority on the Appeal of Shri A.V. Baokar (third party) in the disciplinary matter.

3. By Further letter dated 10.01.2019, you have stated that information sought concerns the life or liberty of a person and requested for providing information within 48 hours. In this regard, this is to state that, you and the said third party, both are employees of Mumbai Port Trust and the copies of documents sought by you cannot be treated as information concerning life or liberty, neither of RTI applicant nor of said third party.

4. The abovesaid information (copies) sought by you, relates to the personal information of Shri A.V. Baokar. Therefore, as per provision in Section 11 of RTI Act 2005, consent of Shri A.V. Baokar was sought vide this office letter no. TM/M/13-5/ RTI/197/92/4862 dated 14.01.2019. In reply, Shri A.V. Baokar, vide his letter dated 22.01.2019 has requested this CPIO **not to disclose** the information to Shri Anilkumar Laxman Kambli.

5. This CPIO does not find any larger public interest for disclosing the information.

6. Section 8 (1) (j) of RTI Act, 2005 reads as under:-

“ information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information”.

7. In view of above, the requested information can not be provided under the provisions of Section 8 (1) (j) of RTI Act.

8. In case you are not satisfied with the reply, you may appeal to Smt. S.G. Patwardhan, Sr. Dy. Secretary, MbPT and the First Appellate Authority, 2nd Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai – 400 001 against the same. Her email ID and contact number is spatwardhan@mbptmail.com and 66564047. The period within which appeal could be preferred is 30 days from the date of this communication. The prescribed format of appeal/petition (Annexure D) is enclosed.
