2. In this regards, it is to bring to your notice that earlier, vide your RTI application dated 10.01.2018 you had sought the information about details of Hamal Labour who have died while in service during the year 1971 to 1973 and also details of Hamal Labour whose IC No. is 1242. The information was provided to you vide this office letter no.TM/M/13-5/RTI/197/90/4471 dated 05.02.2018 sent by registered post and receipt of the same was acknowledged by you.

3. Also, vide your another previous RTI application dated 26.11.2018 you had sought the information about employee having IC No. 1402. The information was provided to you vide this office letter no.TM/M/13-5/RTI/197/90/4471 dated 18.12.2018 sent by registered post and receipt of the same was acknowledged by you.

4. Thus, your this RTI application dated 15.01.2019 is repeat RTI application of your previous RTI applications dated 10.01.2018 and 26.11.2018 seeking similar information.

5. Central Information Commissioner (CIC) vide one of the orders held that the repetition of information request may be considered as reasonable ground for refusal under the RTI Act.

6. However, as regards to Labours who have died while in service during the year 1970 to 1974, it is reported by the concerned Section that, such records are not available.

7. As regards to other information sought by you in RTI application dated 15.01.2019, since, the information sought is already provided by this office replies dated 05.02.2018 and 18.12.2018, same being repetition, stands rejected.
