Ref:- Your RTI application dated 28.01.2019 received in office on 01.02.219.

Vide your RTI application dated 28.01.2019 received in the office on 01.02.2019 you have sought information about A) Documents submitted by Mr. Augastin Kadam (Pension – 0032581) & (PF D0009607) to get his pension started, B) By what procedure pension has been started of above mentioned person.

- 2. Accordingly, assistance from concerned section of Traffic Department, was sought under Section 5(4) of the RTI Act, 2005.
- 3. The details required by you, relates to the personal information of Shri Augastin Lucas Kadam such as Bank Account details, his address, photocopies of Bank Pass Book, PAN Card, Aadhar Card, Affidavit, letter about nomination etc. under the provisions of Section 8 (1) (j) of RTI Act. Therefore, as per provision in Section 11 of RTI Act 2005, consent of Shri Augastin Lucas Kadam was sought vide this office letter No. TM/M/13-5/RTI/197/102/5397 dated 13.02.2019. However, in reply, Shri Augastin Lucas Kadam, vide his letter dated 21.02.2019 has not given his consent to give the information.
- 4. Section 8 (1) (j) of RTI Act, 2005 reads as under:-
  - "information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information".

- 5. In view of the objection of Shri Augastin Lucas Kadam, the reply is provided as under:
  - i) The information sought at para 4 (iii) (A) of your RTI application being personal information is exempted from disclosure under Section 8 (1) (j) of RTI Act, 2005. In view of denial by third party as stated above in para 3 (i.e. Shri Augastin Lucan Kadam) the same cannot be provided.
  - **ii)** 4 (iii) (B): Following procedure is followed by Traffic Department in forwarding of Pension case of Shri Augustin Lucas Kadam, ExSanitary Health Worker to Pension Branch, Accounts Department.
  - a) Submission of Form 'F' and 'E' alongwith requisite documents and Affidavits by Shri Augastin Lucas Kadam.
  - b) Verification of record of Form 'F' and 'E' alongwith requisite documents submitted by employee indicating bank details, copies of PAN and Aadhar card and written application submitted by employee alongwith CRS order dated 16/09/2013 and after obtaining service, leave particulars and Vigilance Clearance of the employee, the same was forwarded to the Pension Branch of Accounts Department of Mumbai Port Trust.
- 6. In case you are not satisfied with the reply, you may appeal to Smt. S.G. Patwardhan, Sr. Dy. Secretary, MbPT and the First Appellate Authority, 2<sup>nd</sup> Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai 400 001 against the same. The period within which appeal could be preferred is 30 days from the date of this communication. The prescribed format of appeal/petition (Annexure D) is enclosed.
