Your aforesaid RTI application is received online on 03.04.2019 from Shri. S. K. Sharma, Sr. Dy. Material Manager & CPIO, Materials Management Division of Mumbai Port Trust.

2. The information sought by you is - "Who many tonnes of waste is received at the Mumbai Port".
3. The information sought is not understood. The Traffic Department of Mumbai Port Trust (for which undersigned is CPIO) deals with the import / export cargo handling and is not presently dealing with the waste (i.e. garbage) generated in Mumbai Port.
4. Therefore, this CPIO vide e-mail dated 04.04.2019 sent on the e-mail provided by you in your RTI application, has requested to kindly clarify what exactly you mean by "waste is received at Mumbai Port Trust". Does it mean about normal solid waste generated in Mumbai Port Trust or any other meaning? Period is also not stated.
5. Further, vide letter no. TM/M/13-5/RTI/197/3/151 dated 08.04.2019 sent by Registered post, this CPIO has again requested clarification on the information sought by you.
6. Vide e-mail dated 16.04.2019 it was again requested to clarify about the information sought by you.

7. In spite, of all the efforts taken to obtain the clarification on the information sought, to enable this CPIO to provide the requisite information no response received from you.

8. Since, no response is received from you, this CPIO is unable to provide the requisite information.

9. In case you are not satisfied with the reply, you may appeal to Smt. S.G. Patwardhan, Sr. Dy. Secretary, MbPT and the First Appellate Authority, 2<sup>nd</sup> Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai - 400 001 against the same.
