Sir,

Your online RTI application dated 17.11.2020 received in this office on 03.12.2020 from Shri R.W. Khare, Accounts Officer, Gr. I (T) & CPIO, Finance Department, Mumbai Port Trust which he received from Ministry of Shipping on 17.11.2020 under registration no. DSHIP/R/E/20/00164, wherein you have requested to provide information about travelling allowances paid to government employees during COVID-19.

2. Accordingly, assistance of the concerned offices of the Traffic Department have been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

3. On the basis of the information received from the concerned officers of Traffic Department the information / reply pertaining to Traffic Department is as under :

1	Please inform me if any or all of the Mumbai based offices under Ministry of shipping has followed instruction issued by ministry during COVID 19 lockdown and unlock.	Yes, all instructions issued by Ministry during COVID-19 lockdown & unlock have been followed by this section.
2	Please inform me if any or all of the Mumbai based offices under Ministry of shipping have provided home to office and office to home transport facility to its employees during COVID 19 lockdown and unlock.	(j) CISF Bus service between Nadkarni Park, Wadala and Docks was provided by Mumbai Port Trust from 22.03.2020 IIIrd shift which was discontinued from 11.07.2020. (ii) BEST was running buses between New Yellow Gate, Indira Dock and Borivali, Kalyan and Panvel from 26.03.2020 which were discontinued From 06.07.2020. Charges were paid by employees travelling.

3	With respect to point 2, Please inform me if whether travelling allowance was paid to the employees availing transport facility by office.	Details of the employees who have used the CISF bus facility is not available.  The reimbursement of bus fare collected from the employees by BEST for special buses (Rs. 50/- per return trip) on production of tickets was sanctioned vide TR No. 315 dated 27.03.2020. However, none of the employees of this Department have claimed the reimbursement.
4	Please inform me if any government employee can get travelling allowance and transport facility at the same time.	Travelling allowance is paid through salary to all the employees who are present on duty eventhough they have used transport facility.
5	Please inform me about amount of expenditure incurred by Mumbai based offices under ministry of shipping for home to office and office to home transport facility to its employees during COVID 19 lockdown and unlock.	The information is not available.
