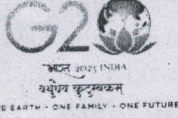

Subsequently, in the year 1994 name of "Mrs. Changunabai" as wife was deleted, citing reason as legally divorced and declared "Mrs. Manda" as wife.

In case you are not satisfied with the reply, you may appeal to Traffic Manager and the First Appellate Authority, Traffic Department, Mumbai Port Authority, 1st Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai - 400 001 against the same.
