Sub.: Information sought under RTI Act, 2005

Ref.: Your RTI application dated 02.02.2023.

This has reference to your captioned RTI Application dated 02.02.2023 to furnish information regarding details and information of Bombay Sand Supply.

2. Accordingly assistance of the concerned office of the Traffic Department has been sought as per the provisions under Section 5(4) of the RTI Act, 2005 and the information obtained is furnished as below:

Bombay Sand Supply as 302, Colaba Plastic Market, 146/152, Samuel Street, Mumbai-400009 is not available in this office.
3(b)	Also require details and information of the total outstanding payment on above company till date alongwith details from which year the permission for dischargeing sand was given to Bombay Sand Supply	a) It is to state that as per the guidelines for public authorities under RTI Act 2005, it is not required to create information, to interpret information or to furnish replies to hypothetical questions like which, why and how and under what circumstances under RTI Act 2005. Furthermore the information sought would disproportionately divert the resources of the public authority, thus the reply cannot be furnished as per section 7(9) of the RTI Act 2005.
3(c)	Require details as to how Bombay Sand Supply pay charges to Mumbai Port Trust since last ten (10) years with (1) Name of Bank & (2) Account details.	b) In terms of section 8(1) (e) of RTI Act 2005, the information held in fiduciary relationship cannot be provided. c) Section 8(1) (j) of RTI Act 2005, exempts the information which relates to personal information the disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual.

4. In case you are not satisfied with the reply, you may appeal to Shri. B. S. Shinde, Traffic Manager and the First Appellate Authority, Traffic Department, Mumbai Port Authority, 1st Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai - 400 001 against the same.
