Sub: Table space on casual occupation basis at erstwhile Cotton Depot station provided to Carting Agents Association --Extension of facility.

With a view to attract rail borne traffic and to utilise the infrastructure provided at Cotton Depot, the Carting Agents Association members were permitted use of table spaces admeasuring 2 mtr. x 2 mtr. = 4 sq.mtrs. on casual occupancy basis, subject to the following conditions, for a period of one year w.e.f. 01.01.2003, as approved by Chairman, MbPT.

- Use of table spaces will be on Casual occupancy basis for which recovery of 1. charges will be at the rate of Rs.2/- per sq.mtr. per day under bye laws no. 9 of the Mumbai Port Trust General Bye-laws at present or the charges as revised from time to time.
- 2. The Association will pay in advance before 10th day of every month for all the table spaces permitted to use. Interest on the delayed payments will be charged as per the existing rules.
- Occupancy is on casual basis and no tenancy or lease or licensee rights 3. whatsoever will be granted.
- The table space allotted shall have to be used by the allottee for the purpose for which it is allotted, failing which the facility will be withdrawn and action as provided under General Bye-Laws No. 9 will be taken.
- Necessary service tax at the applicable rates shall be paid by the Association 5. alongwith the monthly advance payment.
- Association will be asked to indicate the exact requirement alongwith the details 6. of the agents to whom it proposes to allot the table spaces .
- This arrangement will be effective till this portion of Cotton Depot erstwhile station structure is required for Mumbai Port Trust operational use or as this Port may decide.

During the year 2003, the Association members have adhered to the above conditions and the total amount collected towards the casual occupancy charges amounts to Rs. 71,424/excluding service tax, has been recovered.

The Assosciation has requested vide his letter dated 26-12-2003 for allotment of 12 table spaces w.c.f from 01-01-2004.

Subject to approval of Chairman, use of table spaces at Cotton Depot will be permitted for a further period of one year w.e.f. 1st January 2004.

With reference to your letter referred above; storage of subject consignment is permitted for a period of 30 days at 'G' Shed, Grain Depot, under the provisions of Section 3.3 (A) (II), Chapter III of Scale of Rates and Circular Nos. TM/D/4-3/19 of 1996-97 dated 05.09.2008 and TM/A/15-22/29 of 1995-96 dated 11.12.08 @ Rs.40/- per sq. mtr. or part thereof per month or part thereof, subject to compliance of following conditions:

- The cargo should be out of charge from Customs and cleared from the Transit shed on completion of Port and Customs formalities.
- 2) You shall remove cargo to the allotted site at your own risk and cost.
- The storage of the cargo at allotted site shall be solely at your risk, cost and responsibility.
- 4) Prior to shifting the cargo to the allotted site, you shall make advance payment of license fees at the rate of Rs.40/- per sq. mtr. for a month at the Cash Offices in Indira Dock, P & V Docks or STP, for the area requested i.e. 4000 sq. mtrs. - 7) The allotment shall be initially for a period of one month and in case of further extension for allotment of the storage area, you should make an application and obtain permission from this office at least 7 days prior to completion of the 30th day.
- 8) Further extension of the allotment shall be subject to availability of space.
- 9) The area actually occupied by the cargo shall be measured by the Shed Supdt. and will be certified for recovery of license fees.
- 10) You are allowed to use MOD link Road for movement of loaded trucks from Docks to Open area at 'G' Shed, Grain Depot.
