Point No.3(1): Not pertaining to Railway Division, Traffic Department.

Point No. 3(2): As per records, there was a mobile tower erected unauthorisedly on plot no. 2 & 2A, Coal Depot, Sewree, Mumbai by M/s Suyog Telematics Ltd.

Point No.3(3):

- The matter was bought to the notice of Sr. Police Inspector, Sewree Police Station by the Railway Manager vide letter dated 01/12/2016.
- Vide letter dated 31/01/2017 from Asstt. Security Officer (Sr.) addressed to the Railway Manager informed that on 28/01/2017, it was reported that the representative from M/s Suyog Telematics Ltd. was removing the material from the site without any valid permission, thereby a tempo loaded with the material was taken into custody of the office of Chief Security Officer, MbPT.
- The Dy. Estate Manager II vide letter No.EM/U-4/Removal addressed to M/s Suyog Telematics Ltd., had instructed to deposit an amount of Rs.4,00,310/towards charges for unauthorized construction of mobile tower in MbPT estate.
- The Station Master, Grain Depot, MbPT Railway vide his letter dated 26/04/2017 addressed to the Railway Manager had informed that M/s Suyog Telematics Ltd. had made the required payment of Rs.4,00,310/- in the Cash Office of Estate Department. Further, he also mentioned that after the payment was verified by the Chief Security Officer, the unauthorized structure was removed entirely from the area on 20/04/2017 and confiscated material was released by the Chief Security Officer, MbPT.

Point No.3(4): Please refer Point No. 3(3).
