SUB: GUIDELINES FOR REFERRAL OF MBPT PATIENTS TO THE EMPANLED HOSPITALS / DIAGNOSTIC & IMAGING CENTERS / EXCLUSIVE EYE HOSPITALS / EXCLUSIVE DIALYSIS CENTERS / EXCLUSIVE CANCER HOSPITALS FOR THE SERVICES NOT AVAILABLE IN THE MBPT HOSPITAL.

In supersession of the earlier Circular No. 12964 dated 15.03.2018 on the above-mentioned subject, the circular has been revised by incorporating the names of the new empaneled hospital and diagnostic centre and other provisions.

The Board of Trustees of the Port of Mumbai vide TR Nos. 97 dated 8.9.2017, TR No. 119 dated 13.10.2017, TR No. 168 dated 27.11.2017, TR No.173 dated 09.01.2018, TR No.207 dated 13.03.2018, TR No. 33 dated 30/05/2018, TR No. 72 dated 02/07/2018, TR No.93 dated 02/08/2018, TR No. 101 dated 02/08/2018 & TR No. 180 dated 13/11/2018 has accorded approval for empanelment of the following Super-specialty/Multi-specialty Hospitals / Diagnostic and Imaging Centers / exclusive Eye Hospitals / exclusive Dialysis Centers / exclusive Cancer Hospitals under the panel of Mumbai Port Trust Hospital.

II. The Board of Trustees of the Port of Mumbai Vide TR No. 119 dated 13.10.2017 has accorded approval

- (i) to extend treatment on full credit basis to the Retirees and their spouses in the empaneled Hospitals at par with serving employees as per MbPT Standard Rates for package items and Standard Percentage of Discount for Non-package items of treatment in the following life threatening conditions namely:
 - (a) Acute Heart Attack

- (b) Coronary Angiogram
- (c) Coronary Balloon Angioplasty with Stenting & Percutaneous transluminal coronary angioplasty (PTCA) without any limitation in number of stents for acute Heart Attack or as a preventive measure for Heart Attack.
- (d) Coronary Artery Bypass Graft (CABG) Surgery for Heart vessels blocks.
- (e) Temporary or Permanent pacemaker implantation surgery in sudden Heart Blocks.
- (f) Peritoneal Dialysis & Hemodialysis for Acute and Chronic Kidney failure.
 - (g) Brain Attack cases Cerebro vascular accidents (CVA).
- (h) Life threatening Road Traffic Accidents.
- (i) Kidney Transplant for both Live or Cadaveric donor.
 - (j) Liver Transplant for both Live or Cadaveric donor.
- (ii) to reimburse all the eligible reimbursement of claims submitted by serving employees for the treatment taken in case of emergency admissions other than the approved empaneled Hospitals based on the MbPT Standard L1 Rate for package items and Standard H1 Percentage of Discount for the non-package items instead of the existing practice of Bombay Hospital (Not participated in the Tender for empanelment) Rate.
- III. The Board of Trustees of the Port of Mumbai Vide TR No. 150 dated 10.11.2017 has accorded approval
- the credit facilities to the retirees and (i) To extend the above empaneled Hospitals to a Maximum spouses in of CGHS Rate and the difference amount between Rate and the MbPT Standard Rated for package of Discount for Non-package Percentage and Standard items will be paid directly to the Hospital by the retirees declaration/consent submitted by the retiree based on the at the time of referral to empaneled Hospitals.
- (ii) To extend full credit facilities to the retirees and their spouses at par with serving employees at Tata Memorial Hospital & Research Centre for all cancer treatments at TATA Hospital rates which is more or less equal to CGHS Rates.

The Board of Trustees of the Port of Mumbai vide TR NO. 187 dated 09.01.2018 has accorded approval to the following Guidelines to implement the transparency in the referral system of patients is as under:

Guidelines 1

: The method of choosing the hospital/Diagnostic centers for referral, the treating doctor first preference choice must be to the Private Hospitals under CGHS rate failing which Private Hospitals under Standard MbPT Rate. (if the patient desires, he will be referred to Government Hospitals/Municipal Hospitals)

Guidelines 2 : List of Govt. / Municipality/Private Hospitals/ Diagnostic Centers in all the categories to be shown to the patients/Relatives of the patients.

Guidelines 3

Referral to Private Hospitals/Diagnostic Centers should be specific services /Specialty e.g. CABG, not vague like "Admission and further treatment".

Guidelines 4

Referral should be to the Private Hospitals/Diagnostic Centers closest to the Residence of the Patients.

Guidelines 5

: If the Patient is not sure of the Private Hospitals/Diagnostic Centers, the referring doctor should explain the Pros & Cons of the Hospital where the facility is available.

Guidelines 6

If the patient is still not sure, then the referral should be on rotation basis among the Private Hospitals/Diagnostic Centers, no specific Private Hospitals/Diagnostic Centers should be targeted.

Guidelines 7

Only those retired employees who are willing to pay the difference amount between CGHS Rate and the Standard L1 Rate for package items and Standard H1 Percentage of Discount on the individual Hospital Rates /MRP Rates for non-package items should be referred to the empaneled Private Hospitals/Diagnostic Centers. The patient should be informed that he/she has to pay the difference amount directly to the Hospital.

Guidelines 8

Those Retired employees who want 100% cashless treatment should be referred to those empaneled Private Hospitals/Diagnostic Centers who have agreed for CGHS Rates.

Guidelines 9

In Emergency life threatening conditions, decision of the treating doctor is final based on the condition of the patient and availability of facility in empaneled Hospitals and can prefer to nearest empaneled Private Hospitals / Diagnostic Centers.

Guidelines 10

In Elective & Planned referrals, approval of the Head of the concerned Faculty and in-turn approval of CMO is must. In Emergency life threatening conditions, decision and approval of treating doctor is sufficient, subsequently expost-facto approval of the Head of the concerned Faculty and in-turn approval of CMO is must.

Guidelines 11

Before approving the referral, the decision of Chief Medical Officer, Mumbai Port Trust is the final.

Guidelines 12

As per sanction of the competent authority by Window no. 2536 dated 16.9.2016, the patients can be admitted in any hospital nearby to their residence for the following life threatening conditions and the reimbursement will be allowed as per MbPT existing regulations:

- 1. Acute Heart Attack
- 2. Acute CVA (Infra cranial bleed) leading to Hemiplegia
- 3. Life Threatening Road Traffic Accidents
- Snake Bite
- 5. Sever Hemorrhage/shock
- Coma of any cause
- Burns more than 30%
- 8. Acute Epileptic Convulsions (Seizures Disorder)
- 9. Foreign Body in Nose or Throat
- 10. Acute Poisoning
- 11. Any Paediatric Emergency under the age of 5 years
- 12. Emergency Cesarean Operation
- 13. Road Traffic Accident with Communicated Fractures
- V. The Board of Trustees of the Port of Mumbai vide **TR No. 215 dated 13.03.2018** has accorded approval to implement CGHS rate Mumbai including Diagnostic Investigation, CGHS rate to all Non-Port Trust Patient (NPT) for the treatment provided at MbPT hospital with effect from the date of Board's approval.
- VI. The Board of Trustees of the Port of Mumbai vide TR No.. 180 dated 13.11.2018 has accorded approval to provide outsourced Cardiac ambulance for transfer of patient in life threating conditions from MbPT Hospital to all the empaneled Hospitals on credit basis at the existing rate of Rs. 2500/- per trip initially for a period of one year through M/s. Lifestar Cardiac Ambulance Services

All the doctors /part time Visiting Consultants of MbPT Hospital are hereby directed to implement the Board Approved Guidelines with immediate effect.

All the Officers/Employees and their family members, Retirees and their spouses and CISF employees & their family members are directed to co-operate the Medical Department to implement the above Board Approved Guidelines.
