**Sub: Tariff for Cruise Vessels coming with crew
only for crew repatriation (Corona Pandemic)**

Pursuant to request for clarification received from Trade regarding levying of Tariff for Cruise vessels coming with crew only for crew repatriation, the Board in its meeting held on 21.09.2021 accorded approval, inter-alia, to the following:

- (i) Consider such cruise ships arriving for mass crew repatriation in emergencies for composite port charges.
- (ii) Consider special cases of mass repatriation of crew, bunkering, taking all essential supplies as cruise calls, as they are essential for regular uninterrupted cruise operations.

Contd..

(iii) Accordingly, cruise ships arriving at Mumbai Port for repairing and survey for the repair purpose will not be considered as cruise calls for the purpose of levying composite Port charges. The following set of charges will be applicable for such cruise ships:

- a. Pilotage,
- b. Port Dues,
- c. Berth hire charges or anchorage,
- d. Any other charges as per services availed.
