Dear Sirs,

Sub: Revised comprehensive Scale of Rates of Mumbai Port Trust effective from 10.04.2021.

by TAMP vide order No. TAMP/5/2019-MbPT approved dated 23.08.2019, MbPT Scale of Rates (SOR) were revised with effect from 03.10.2019. Also as per the Clause 1.2 (xvi) (a) of SOR, 'The SOR is subject to automatic annual indexation at 100% of the WPI to be annually announced by the Authority. The next annual indexation will be from 1 April 2020 subject to the MbPT achieving the Performance Standards notified alongwith the SOR. If Performance Standards prescribed in the SOR are not achieved, there will be no indexation in SOR for that particular year'.

- TAMP vide its e-mail dated 22.04.2020 had informed that 'Considering 100% of variation in WPI occurring between 1st January 2019 and 1st January 2020, the Authority has approved, annual indexation of 1.88% for computation of indexed ARR as per Claus 2.3 of the Tariff Policy 2019 for the year 2020-21 and also for automatic indexation of SOR by Major Port Trusts subject to relevant clause prescribed in the SOR flowing from Clause 3.2 of Tariff Policy 2018. The indexed SOR shall be effective from 1st May 2018 and shall be valid till 30 April 2021'.
- Port has achieved cargo related committed performance standards. Implementation of the indexed SOR for cargo related charges was kept on hold in the light of Covid-19 pandemic. However, now it has been decided to avail the abovesaid escalation of 1.88 % in cargo related charges and accordingly new rates (Chapter III, IV, V, VI & Section 9.4 of SOR) will be effective from 10.04.2021. The revised Scale of rates will be published on website www.mumbaiport.gov.in.
- It may please also be noted that payment of advance deposit and billing towards all charges will have to be made as per revised Scale of Rates effective from 10.04.2021.
