SUBJECT: Permission to ply passenger Speed Boats between Domestic Cruise Terminal and Belapur

Mumbai Port Trust shall give plying permission to passenger speed boats intending to ply between Domestic Cruise Terminal and Belapur under section 6.1(k) of Indian Ports Act 1908 and Passenger Boat Rules 1962 subject to the following terms and condition;

1. Requisite valid documents will be required for issuing Passenger Boat License:
 - a) Vessel Registration Certificate
 - b) Survey Certificate
 - c) Hull & Machinery Insurance (including Wreck Removal Clause)
 - d) Passenger Insurance as per Passenger Boat rules sec 9 and sec 11
 - e) Port Charges (Port dues, Water Conveyance, Passenger Levy, License fee etc.).
2. All the charges/dues shall be collected as per SOR or any other required charges from time to time shall be borne by the owner.
3. Following Rules & Regulations are to be adhered by the crafts holding Licenses.
 - a) License is an identification system and not a title system. A boat license does not provide clear title or ownership of a boat.
 - b) Rules and Regulations to be observed by the Licensee. Any breach will render you liable to penalty provide for the offence.
 - c) Where ever possible this License to be displayed at a prominent place of the craft, in any case to be on board the craft all the time.

- d) To be renewed immediately after 1st April each year.
- e) The craft shall not be plied in the Harbour without a licensed Master/Serang/Tandel as applicable.
- f) This license is not transferable without first obtaining sanction from this department which shall be duly endorsed therein.
- g) Any change in particulars should be notified immediately or else this license is null and void.
- h) Licensee shall operate only for purpose for which license has been issued and not for any activity without explicit permission of the Licensing authority.
- i) Licensee shall be fully responsible for the safety of the crew and other occupants of his craft.
- j) When launch is carrying goods/ship stores/Baggages etc. the number of passengers to be reduced for every 65 kilo 1 passenger.

The Port reserves the right to include/exclude any terms and condition from time to time as and when required and applicable. The port reserves the right to suspend/terminate the license.
