Sub: Pre-Shipment facilities for storage of
Export Sugar at Indira Dock.

Ref: This office circular Nos.:

- (i) TM/A/15-22/25 of 2014-15 dated 10.10.2017
- (ii) TM/A/15-22/04 of 2014-15 dated 04.05.2018
- (iii) TM/A/15-22/31 of 2014-15 dated 01.11.2018
- (iv) TM/A/15-22/09 of 2019-20 dated 04.06.2019.

In continuation of above referred circulars and in view of requirement of covered areas for storage of sugar for exports, Shed Nos. 12A, 13A and 12B ID Temporary Shed are notified as pre-shipment storage area for export of sugar with free period of 30 days.

2. (a) In terms of Circular No. TM/A/15-22/35 dated 04.01.2021, the concessional rate of demurrage applicable for export of sugar is as under:-
 - (i) to allow first 30 days free i.e from Day 1 to Day 30;
 - (ii) to levy flat demurrage rate of Rs.88/- per tonne per month from 31st day to 60th day;
 - (iii) to levy demurrage charges as per section 3.1(B) of Scale of Rates (SOR) from 61st day onwards

- (b) Further, it has been decided to grant `Volume Discount in Stevedoring Charges for exporting sugar from Mumbai Port as below:

“If an exporter has shipped 50,000 tonnes or more of sugar within 12 months period from 01.01.2021 to 31.12.2021, they shall be eligible for 20% rebate in Stevedoring Charges.”

3. The above pre-shipment storage facility is valid upto 31.12.2021.
4. You are requested to give wide publicity amongst your members to avail the facility and to route the cargo through Mumbai Port.
