Sub: Pre-shipment facilities for storage of export cargo.

- Ref : 1. This office circular No. TM/A/15-22/21 of 2014-15 dated 20.11.2020.
2. This office circular No. TM/A/15-22/41, 51 & 56 of 2021-22 dated 25.02.2021, 23.04.2021 & 19.05.2021 respectively.

By above-referred circular dated 20.11.2020, the facility of 21 free days for pre-shipment storage of export consignments of Iron and Steel at the following locations of Indira Dock was extended for a period of one year from 12.11.2020 to 11.11.2021:

Sr. No.	Location	Commodity
1.	13A ID, 13B ID, 15ID Sheds.	Iron & Steel requiring covered area.
2.	4 ID and 14 ID open areas.	All Iron & Steel requiring open storage area.

2. Also, in view of spurt of export cargo and civil repairs to some covered shed in Docks, by above-referred circulars dated 25.02.2021 and 25.04.2021, 12 ID Shed was nominated as a pre-shipment storage facility (for 21 free days) for export consignments of Iron & Steel in addition to shed mentioned at para 1 above. This facility is valid till 24.07.2021.


3. Further, some of the sheds in Indira Docks had suffered damages mainly to their roofs on 17.05.2021 due to cyclone Tautke and shortage of covered storage space for storage of export iron & steel was experienced. Hence, in order to tide over the above-said situation by above-referred circular dated 19.05.2021, shed no. 20 ID was nominated as a pre-shipment storage facility (for 21 free days) for export consignments of Iron & Steel in addition to shed mentioned at para 1 and 2 above, for 02 months from 19.05.2021. This facility is valid till 18.07.2021.

4. In view of the ongoing monsoon and spurt in Iron & Steel export cargo, the pre-shipment storage facility (for 21 free days) at Shed no. 12 ID & 20 ID for export consignments of Iron & Steel cargo is further extended till 30.09.2021 and to be reviewed thereafter.

5. On expiry of 21 free days from the date of receipt of export cargo of Iron and Steel at above locations of Indira Dock, demurrage shall be levied from 22nd day onwards, as per the SOR provisions.

6. You are requested to give wide publicity amongst your members about the said facility and to bring more export cargo for shipment through Mumbai Port.
