Sub: Announcement of 12 specific exemptions in Shahid Beheshti Port, Islamic Republic of Iran.

12 specific exemptions are announced by PMO, Islamic Republic of Iran, in Shahid Beheshti Port in order to establish more suitable port infrastructure and for providing special incentives and encouraging businessmen to utilize this route for transshipment of cargo. These 12 exemptions announced by the Govt. of Iran are listed below:

- i. Three-month exemption in warehousing of mineral and construction of goods for all customs procedures.
- ii. 50% discount on Terminal Handling Charges (THC) in foreign transit containers in Shahid Beheshti Port.
- iii. 87% discount on Terminal Handling Charges (THC) in foreign transit containers.
- iv. 75% discount on the Terminal Handling Charges (THC) for full containers in transship.
- 46% Discount on the Terminal Handling Charges (THC) for empty ٧. container in transship.
- vi. 87% discount on warehousing of transshipping.
- vii. 100% exemption on Terminal Handling Charges (THC) for empty containers entering Shahid Beheshti Port only for stuffing and sea transportation.

- viii. Three-month exemption in warehousing of empty container entering port for loading and unloading cargo.
- ix. 30% discount on container loading and unloading (THC) costs compared to other southern ports of the country.
- x. 75% discount in warehousing of container in import as well as returned imported cargo.
- xi. 25% discount on THC of different containers in export and re-export as well as returned exported cargo.
- xii. 80% discount on warehouse in export re-export and returned cargos.
- 2. In this regard, it is requested to communicate the 12 exemptions to all concerned Shipping Companies so as to promote business in Chabahar Port.
- 3. Shipping companies may be requested to utilize this route for transshipping cargoes and goods so as to give more opportunities for investors in Iran.
