dated 18.10.2019 and 28.05.2020 respectively.

By above-referred circular dated 18.10.2019, the facility of 21 free days for preshipment storage of export consignments of Iron and Steel at the following locations of Indira Dock was extended for a period of one year from 12.11.2019:

- 2. By above-referred circular dated 28.05.2020, 13A ID Shed was also notified for pre-shipment storage of export consignments of Iron & Steel only in addition to above locations, with 21 free days till 11.11.2020.
- 3. The facility of 21 free days is now extended for a further period of one year from 12.11.2020 to 11.11.2021, for pre-shipment storage of export consignments of Iron and Steel only, at following locations:
