Sub : **Storage facilities for import Gypsum at
Mumbai Port Trust.**

Ref : **This office Circular No. TM/D/4-3/M-230 dated
16.03.2020.**

By this office circular referred above, Trade was informed about Board's approval for the storage of Gypsum and other such Bulk Cargo in the notified areas upto 180 days on License Fee basis for a period of one year from 16.03.2020, at the rates specified therein.

2. Board has accorded approval for the extension of the facility of storage of Gypsum in the notified areas for further 2 months in addition to 180 days on recovery of charges as under: -



Sheds	First 15 days or part thereof	1.50

Open Yards	First 15 days or part thereof	1.00
	16 th day to 240 th day	1.50
Sheds/ Open Yards	241 st day onwards	20.00

3. It should be noted that trade will have to pay revised Licence Fees as and when revised by the TAMP and also when the Mumbai Port Trust (General Management of Port) Regulations comes into effect.

4. These being bulk cargoes, the precautions for pollution control measures will have to be taken by the consignees/their handling Agents, as would be intimated from time to time, during handling, transport, storage, etc.

5. You are requested to inform your members accordingly and bring more cargo to the Port.
