Sub: Storage facility for import pulses at 12A ID and 12B ID Sheds for Storage of Pulses under Provision of Section 3.3 (A)(II) of Chapter III of Scale of Rates (SOR) for the period of 60 days from VCD.

Vide Circular No. TM/A/15-33/28 dated 30/11/2019 12B ID Temporary Shed was nominated for storage of Import Pulses up to Maximum of 60 days from Vessel Completion Date (VCD) of the Vessel on recovery of storage fees in terms of provision of Section 3.3(A)(II) of Chapter III of the Scale of Rates (SOR). From 61st day onwards from VCD, the cargo will attract demurrage at rates specified in Section 3.1(B) of Chapter III of the Scale of Rates (SOR).

2. Due to increase in import pulses consignment two sheds 12B and 12A have been nominated for long term storage of Import Pulses under the provision of Section 3.3(A)(II) of Chapter III of scale of Rates (SOR) for the period of 60 days from the Vessel Completion Date (VCD) of the Vessel. From 61st day onwards from VCD, the cargo will attract demurrage at rates specified in Section 3.1(B) of Chapter III of the Scale of Rates (SOR).

- 3. Wharfage charges on the entire consignment shall be paid by the Consignee / CHB before completion of discharge of pulses from the Vessel.
- 4. The above scheme will be valid for a period of 6 months from the date of issuance and it will be reviewed there after.
- 5. You are requested to give wide publicity amongst your members to avail of the facility.
