**Sub : Storage facility for import pulses at 12B ID
temporary shed under Section 3.3 (A)(II)
of Chapter III of Scale of Rates (SOR).**

All India Pulses & Grains Association (IPGA) had requested for permitting storage of import pulses for 90 days in the docks for stemming the declining traffic of pulses import through the Mumbai Port. The request was discussed with IPGA and to encourage pulses importers to use Mumbai Port, 12B ID temporary shed erected by IPGA was considered for allotment, as an area specified for storage upto a maximum of 60 days on recovery of storage fees in terms of provision of Section 3.3(A)(II) of Chapter II of the Scale of Rates (SOR).

2.1 The request of IPGA was placed before the Board and Board vide TR No. 220 dated 28.11.2019 approved storage of import pulses in 12B ID temporary shed, specified by MbPT for storage upto a maximum of 60 days from Vessel Completion Date (VCD) of the vessel. The cargo shall be stored on recovery of storage fees, in lieu of demurrage, for 60 days from VCD of the vessel. From 61st day onwards from VCD, the cargo will attract demurrage at rates specified in Section 3.1(B) of Chapter III of the Scale of Rates (SOR).

2.2 Wharfage charges on the entire consignment shall be paid by the Consignee / CHB before completion of discharge of pulses from the Vessel.

3. You are requested to give wide publicity amongst your members to avail of the facility.
