Sub: Levy of parking charges for open areas being used by transporters for parking Mobile Cranes, Forklifts and other Cargo/Container Handling Equipment engaged in Docks

Ref: Circular No.TM/A/15-Misc/19 of 2017-18 dated 07.08.2017

In continuation to the above referred Circular dated 07.08.2017 and with a view to regulate parking in the Docks and gainful utilization of Port area, following procedures regarding parking of Cargo/Container Handling Equipments (CHEs) viz., Forklifts, Mobile Cranes, TLTs, Reach Stackers, JCBs, etc., in the operational areas shall be followed with effect from 01.07.2019.

- (i) Port User will desist from parking Cargo Handling Equipments (CHEs) inside Port area, which are not required for regular cargo/vessel operations.
- (ii) Port Users who have opted for Parking Pass shall be required to renew Parking pass on or before the expiry date, else, the occupation of CHE in the Docks will be treated as unauthorised parking. In such case, the Port User shall have to pay penalty of Rs.500/- per Forklift per day and Rs.1000/- per Mobile Crane/TLT/Reach Stacker/JCB, etc., per day, in addition to parking charges as applicable.
- (iii) No CHE will be allowed to enter/exit the Docks from New Yellow Gate, ID (NYGID).
- (iv) In case of loss of VDS of CHE, penalty of Rs.1000/- in addition to Overstay charges, applicable in terms of Circular No. TM/A/15-Misc/19 of 2017-18 dated 07.08.2017 shall be levied.
- (v) Exemption from payment of Overstay charges will be allowed by the Dy. Traffic Manager, Operation-Docks & Cargo Accountal as enumerated at para.2(iv) of the Circular dated 07.08.2017.
- (vi) Any defaults as regards non-payment of parking charges/overstay charges, penalty, etc. and false recommendations/declaration will be viewed seriously and action as per Blacklisting Policy of February 2018 displayed on MbPT website will be taken.
- 2. You are requested to advise your members to strictly comply with the above instructions so as to ensure smooth cargo operations and eliminate unwarranted parking in Docks.
