Sub: Concessional rates for demurrage  
on export of Sugar.

Ref : Circular No.TM/D/4-3/30 dated 01.11.2018.

Vide circular referred above, the trade was informed about the levy of concessional demurrage for agricultural export for a period of one year as under:

- 18.70 per Tonne per day from 1<sup>st</sup> to 20<sup>th</sup> day as against 70.09 per Tonne per day.
- 47.60 per Tonne per day from 21<sup>st</sup> to 40<sup>th</sup> day as against 105.11 per Tonne per day.
- 111.80 per Tonne per day from 41<sup>st</sup> day onwards as against 140.20 per Tonne per day.

This circular will be applicable for agricultural products other than sugar.

2. With a view to encourage sugar export, through Mumbai Port, it has been decided :

- i) to allow first 30-days free i.e. from Day 1 to Day 30;
- ii) to levy flat demurrage rate of Rs. 80/- per tonne per month from 31<sup>st</sup> day to 60<sup>th</sup> day;
- iii) to levy demurrage charges as per section 3.1 (B) of Scale of Rates (SOR) from 61<sup>st</sup> day onwards.

3. Subject concessional rate of demurrage will be applicable for export of sugar for three months and will be reviewed thereafter.

4. All exporters of Sugar are requested to avail the facility and route their exports of sugar through Mumbai Port.

5. You are requested to give wide publicity amongst all your members to avail the benefits of the aforesaid concession.
