**Sub: Annual Escalation factor for ARR computation and
computation of indexed SOR by Major Port Trusts
under Tariff Policy 2015.**

As per Tariff Policy 2015, MbPT Scale of Rates (SOR) were revised with effect from 19.08.2016. In terms of Clause 2.8, 2.9 and 3.2 of Tariff Policy, 2015, the existing SOR will be allowed to be indexed annually to inflation to the extent of 100% of the variation in Wholesale Price Index (WPI) announced by the Government of India occurring between 1st January of previous year and 1st January of the relevant year. Such automatic adjustment of SOR will be allowed subject to the achievement of the performance standards specified in the SOR.

2. Tariff Authority for Major Ports (TAMP) has announced **NIL** escalation factor for the year 2018-19 for the Major Ports Trusts. Therefore, there will be no indexation factor for the year 2018-19 to index the Scale of Rates (SOR).
