Sub : Pre-shipment facility for aggregation of vehicles at 5 ID.

Presently, Gamadia Complex and Gamadia Road extended area [for Heavy Motor Vehicles (HMV)] are earmarked for aggregation and storage of export vehicles under pre-shipment storage facility in Indira Dock.

2. Pursuant to the demand from the port users on the projected steep increase in the volume of export of vehicles, on taking stock of the situation, open storage area at 5 ID admeasuring approximately 5000 sq. mtrs. is also earmarked for pre-shipment storage of export vehicles in Indira Dock.

3. To recapitulate, as in vogue, those who desire to avail 30 free days, shall initially cart their vehicles at RCD or Frere Basin and subsequently shift them to Indira Dock shall be eligible for a free period of 30 days inclusive of the intermediate storage period of 10 days in Indira Dock, be it at Gamadia Complex, Gamadia Road extended area, BPX Car Park area or alongside the Berth.

4. The vehicles carted directly in Indira Dock will have 20 free days and if they are not shipped within the free period of 20 days, Demurrage shall be leviable as per the prevailing scale of rates from the 21st day onwards.

5. The above arrangement will come into force with immediate effect. You are requested to give wide publicity amongst your members and other stake holders to avail the facility and route the cargo through Mumbai Port.
