**Minutes of the Dry Dock Allotment Planning Meeting  
held on 13/9/2013**

-----

The Open Users' Dry Dock Allotment Planning meeting was held at 3.00 p.m. on 13.9.2013 in this office. Representatives of 28 user firms were present at the meeting. Dy. CME, Shri A.B. Udavant, presided over the meeting.

2. At the outset, Dy.CME welcomed all the Dry Dock users present and informed that as usual applications of only those Dry Dock users who are present in today's meeting shall be considered for allotment.

3. Dy. CME informed that for vessels at Sr.Nos.1 & 22, allotments were postponed for accommodating Naval vessel and accordingly the same will be considered initially. Vessel at Sr. No.199 is a MbPT vessel and the same will be considered on priority. Similarly, for vessels at Sr.Nos.16, 65 & 102, references received to consider them on priority. Accordingly, these vessels will also be considered on priority. Also, Naval vessel and vessels of Government agencies are also considered on priority.

4. Applications/requests received from users for interchange of their vessels have been considered and accordingly allotments have been made as per their request.

5. Some of the users informed that their vessels to be deleted from the list as the vessels have been either scrapped or dry docked elsewhere. Accordingly, such vessels have been deleted from the list. User members appreciated such firms for informing MbPT for deletion of vessels from the list of applications since others will be benefited.

6. A copy of the list of Dry Dock applications was furnished to all representatives present in the meeting. A tentative Dry Docking programme for HDD has been drawn scheduled from 08.10.2013. The schedule of tentative programme of Dry Docking as discussed and agreed by the representatives present in the meeting is enclosed. MbPT reserves the right to make changes considering the deserving cases of emergency.

7. On a query, Dy. CME informed that applications received at the last moment cannot be taken in the list, but will be included in the next list.

8. After the meeting, a few users complained that they have not received e-mail intimation about the meeting. MbPT had already informed earlier that although MbPT is sending intimation to Dry Dock users about the meeting, the users were also required to see the MbPT website where Dry dock allotment meeting intimation is displayed.

9. Next Dry Dock allotment meeting is scheduled in the 2<sup>nd</sup> week of December, 2013. Users are requested to keep in touch.
