The National Institute of Oceanography (NIO) will deploy a Data Well Directional Wave Rider buoy (Sr. No. 30731-6) in the sea off Colaba, Maharashtra at 10 m water depth at approximate position, Latitude 18° 55.5'N Longitude 72° 46.1'E, from 04th June 2013 to 31st May 2014. The buoy is 90 cm in diameter (deep orange in colour). The buoy will emit flashes when the visibility reduces. Flash pattern: colour yellow (590 nm), pattern 5 flashes every 20s, standard length 195 cm. A mechanized trawler will used to deploy and retrieval of the buoy as and when required.

A Seaguard current meter (Sr. No. 493) will be deployed at location Latitude 18^o 35.9' N Longitude 72^o 47.4' E, on 04th June 2013 and will be in position up to 15th June 2013. A mechanized trawler will be moored close to deployed instrument for safety of the instrument.

All mariners are required to keep well clear of these buoys.
