The subject work amounting to Rs. 18,24,687.39 was awarded to you vide this office Pre-acceptance letter No. CE T 67/2020/3856 dated 03.11.2020 with a completion period of 2 (Two) months (including monsoon) from the date of release of site. You were requested to make payment of Initial Security Deposit amounting to Rs.42,000/- and Additional Security Deposit amounting to Rs.73,000/- as required under Clause No-6.2 of General conditions of Contract (GCC) within mandatory 21 days of receipt of acceptance letter.

However, you have failed to deposit the required amount within the stipulated period. 2. Instead vide your E-mail & letter dated 03.12.2020 you have stated that you are employing less than 10 employees in the firm hence as per applicable norms, ESIC and PF are not applicable to your firm. This office vide letter No. CE T 67/2020/5237 dated 04.01.2021 communicated to you that as per clause No 6.14 of GCC, Bidder has to ensure compliance with statues and regulations and as per Sr No. 6 of work order read with clause No 7 of GCC, Contractor is required to comply with the provisions of ESIC and EPF and requested to pay ISD & ASD within 7days of receipt of letter.

Your reply under reference iii above informing your regret to go ahead with the given 3. terms and conditions regarding Employees Provident Fund (EPF) & ESIC to this office letter No CE.T.67/2020/5237 dated 15.01.2021 is contrary to the provisions of the tender.

4. In view of above, it is hereby informed that the subject tender is terminated in terms of clause No. 6.3, 9.1 & 32 of General Conditions of Contract for failure to perform obligation under the Contract.

5. Your firm is hereby debarred from participating in all future MbPT Contract for 3 years from taking up any MbPT works/contracts in terms of Clause No. 9.3 of General conditions of Contract (GCC) and intimation of the same will be forwarded to CPP Portal and other Government Organisations.
