Sub: Workshop by Customs on 19.7.2019 "Same Day Clearance".

During the "Same Day Clearance" Workshop, held jointly by Shri Bani Bhattacharya, Chief Commissioner of Customs and Shri Sanjay Bhatia, Chairman, MbPT, various issues were discussed, which would help the trade in "Ease of Doing Business".

One of the issue discussed was related to excessive time taken for delivery of loaded containers and payment of high transportation charges by CHB / Importers. The issue of scanning of containers was also discussed, whereunder CHB/importers have to pay additional transportation charges for movement of containers from MOD to Container Scanning Centre, Wadi Bunder and back.

- 3. The above issues were also inter-alia discussed in the meeting (Chintan Shibir) held by Chairman with all the stakeholders on 19.7.2019. As discussed and decided the following changes will be effected in the delivery / movement of containers as under:
 - (i) All FCL containers discharged from barges in the docks, on landing will be moved to 1 ID Prestack Yard and thereafter such FCL loaded containers will be permitted direct delivery from 1 ID, on completion of all Customs and Port formalities.
 - (ii) All containers moving under the Transshipment Permits from JNPT to MOD at Mumbai Port and earmarked by Customs for scanning shall be taken directly by the Transporter to Customs Scanning Centre at Wadi Bunder and after scanning, the containers will be moved to MOD for further transaction.
- 4. You are requested to inform your members to avail of the above facilities, which will surely help in "Same Day Clearance" of containers / cargo and help in reduction of cost and time for the trade.
