Sub: Workshop by Customs on 19.07.2019 "Same Day Clearance" - Simplification of import procedure.

During the "Same Day Clearance" Workshop, held jointly by Shri Bani Bhattacharya, Chief Commissioner of Customs and Shri Sanjay Bhatia. Chairman, MbPT, various issues were discussed, which would help the trade in "Ease of Doing Business".

One of the issue discussed was related to simplification of import cargo delivery procedure at Mumbai Port by curtailing few stages of documentation.

- 3. The above issues were also inter-alia discussed in the meeting (Chintan Shibir) held by Chairman with all the stakeholders on 19.07.2019. As discussed and decided, the following changes will be effected in documentation for the delivery of import cargo from docks:
 - i) Custom House Broker/Importer who were required to submit E-Delivery Order (E-DO) for doing custom examination, shall now be permitted to have custom examination of the cargo without submission of E-DO. However, E-DO shall be necessary for submission to MbPT for delivery of cargo.
 - ii) After Customs examination, the CHB/ Importer can complete Custom "out of charge" process by payment of Custom duty and thereafter make payment of port charges.
 - iii) The present formalities of CDO forwarding and CDO passing carried out presently at CDO office, Ambedkar Bhavan shall be done away with. The CHB/Importer will have to complete only "Shed Passing" at the location where cargo is stored and examined.
 - iv) The "Shed Passing" will be done at the shed by the Shed Superintendent or Assistant Shed Superintendent only after submission of EDO and verification of documents confirming payment of Customs duty and port charges.
 - v) Thereafter delivery of cargo shall be permitted by the Shed Supdt. and all related details shall be fed in IPOS.
- 4. You are requested to inform your members to avail of the above facilities, which will surely help in "Ease of Doing Business" of containers / cargo and help in reduction of cost and time for the trade.
