Sub: Ease of doing business –
Simplification of procedure for clearance
of Coastal cement in bags – reg.

With a view to enable ease of doing business for coastal cement in bags, the existing procedure has been reviewed. The revised procedure for discharging and clearance of coastal cement in bags shall be as under:

- (i) No landing tally will be recorded by Port and the same will be maintained by Shipping Agent / Surveyor.
- (ii) No delivery gate pass will be issued. Custom House Broker (CHB) / Importer after obtaining the shed passing will be allowed to take delivery of coastal cement cargo on their Delivery Challan, similar to Dry Bulk and Liquid Bulk cargo.
- (iii) The Gate Inspector / Gate Assistant posted at the respective gates after verification of application for clearance for coastal goods viz. payment of Port Trust charges shall endorse "Pass out" remark on "Delivery Challan" as well as on the application for clearance of goods and will allow delivery of the cargo.

- (iv) CHB / Importer after clearance of coastal cement bags will continue submission of the application for clearance of coastal goods, duly endorsed by Gate Staff at CDO for the record purpose.
- The new modified procedure will come into force from 01.03.2021 for the vessels arrived on or after 01.3.2021.
