Sub : Nomination of area at S Plot for storage
of Gypsum under provisions of General Bye Laws.

By Circular dated 22.09.2017, open area admeasuring 10000 sq. mtrs.
at Golden Yard, Wadala was notified for storage of import Gypsum. By circular
dated 14.08.2018, entire area of Golden Yard (Wadala) was notified for storage
of all dry bulk cargo cleared from Docks/ Bunders and for erection of
temporary shed.

2. By Circular dated 16.03.2021, Board's approval was conveyed to the
Trade as regards extension of the facility for a further period of 1 year from
16.03.2021 of storage of MOP and other such bulk cargo in outlying areas for

a period of 180 days. Also for Gypsum cargo, it was informed that Board had approved to continue to give further 60 days beyond above-said 180 days (240 days in all).


3. By Circular dated 21.05.2021, Shed No. MOD-2 and Shed L, K and N Grain Depot were nominated for storage of import Ammonium Sulphate, Gypsum, MOP, MAP and other such bulk cargo on recovery of storage charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates and General Bye Laws, as applicable.

4. By Circular dated 26.10.2021, entire open area of Haji Bunder and covered area of 'C' Shed, Haji Bunder were nominated for storage of import Gypsum and fertilizers viz. Ammonium Sulphate, MOP, MAP, DAP etc., in addition to pulses, cement and Silica Sand on recovery of storage charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

5. In view of demand of the trade, 'S' Plot is nominated for storage of Gypsum cargo on recovery of charges under provisions of General Bye Laws. The above notification of 'S' Plot will be for a period of one year till 10.11.2022 and will be reviewed thereafter.

6. You are requested to give wide publicity amongst your members to avail the above facility.
