**Sub: Extension of concessional box  
rate for stuffing/destuffing of  
containers at Mumbai Port.**

Ref: TM/C/3-93/II/45 of 04-05 dated 05.03.2021 &  
TM/D/4-3/53 dated 28.04.2021.

Vide this office, above referred circular dated 05.03.2021, the concessional box rate for stuffing/destuffing of containers at Mumbai Port was extended for one year with effect from 30.03.2021 and the same was informed to Trade.

2. The Board has now accorded approval for further extension to the above concessional Box Rate for stuffing and destuffing of containers at Mumbai Port for further period from 30.03.2022 till 02.10. 2022. The rates are as under :



Containers having length upto 20'	Rs. 5920	Rs. 6367
Containers having length over 20' and up to 40'	Rs. 11840	Rs.12734
Containers having length over 40'	Rs. 17760	Rs.19101

Note : The above rates are as per revised scale of rates, approved by TAMP, effective from 01.05.2021
