Sub: Pre-shipment facilities for storage of export cargo.

Ref: No.TM/A/15-22/18 dated 17.06.2022.

By above-referred circular dated 17.06.2022, the facility of 21 free days for preshipment storage of export consignments of Iron and Steel at Sheds No. 12 ID and 20 ID was extended till 31.08.2022.

- 2. The above facility was reviewed and due to considerable reduction in export of Iron & Steel cargo in the last couple of months the above said facility for pre-shipment storage cargo at 12 ID and 20 ID was discontinued.
- 3. Requests have been received from trade for preshipment storage facility for 21 free days in additional sheds inside Docks for export cargo of Iron& Steel.
- 4. Also there is shortage of covered storage space in Docks as the pulses cargo of M.V. Ruby seized by customs has occupied major shed area of 13 AID and 15 ID shed, which are also nominated for preshipment storage facility for export consignment of Iron & Steel cargo.

- 5. In view of above, 12 ID & 20 ID is nominated for preshipment of storage of 21 free days for storage of export consignment of Iron & steel cargo. The facility will be valid for 3 months from the date of this circular.
- 6. On expiry of 21 free days from the date of receipt of export cargo of Iron and Steel at above locations of Indira Dock, demurrage shall be levied from 22nd day onwards, as per SOR provisions.
- 7. You are requested to give wide publicity amongst your members about the said facility and to bring more export cargo for shipment through Mumbai Port.
