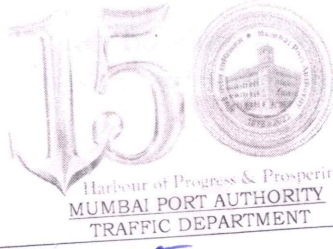

Sub : Risk Based Random Inspection System (RBRIS) - reg.

The Government of India has ratified the ILO-C 81 and the main objective of the above convention is to establish a system of Labour Inspection to secure the enforcement of legal provisions relating to conditions of work and protection of workers while engaged in their work.

In this context, DGFASLI, Ministry of Labour and Employment, Government of India has taken initiative to develop Risk Based Random Inspection system (RBRIS) for enforcing the Dock Workers (Safety, Health and Welfare) Regulations, 1990 framed under the Dock workers (Safety, Health and welfare) Act, 1986 in the majors ports of India as a proactive measures.


This system will help in achieving the statutory compliance without hindering the flow of cargo handling in ports.

The Risk Based Random Inspection System (RBRIS) proforma as enclosed is to be filled up and duly filled-in proforma is to be forwarded to Directorate at the email-id: rbris-ids@dsfasli.nic.in atleast 48 hrs prior to the arrival of the vessel(s) in port.
