ORDER NO. 09 OF 2023-24

WHEREAS, Shri Kiran Takle, had preferred an application dated 01.12.2023 under the Right to Information Act, 2005 to the Central Public Information Officer of the Estate Division of Mumbai Port Authority, which was received in Estate Division on 01.12.2023

2. AND WHEREAS, Shri. Kiran Takle by his application dated 01.12.2023 had sought information as under:

- 1) Tenable repair NOC copy given to Shri. Aziz Ismail Dhariwal & others for Plot No.41,41A, 41B at Mazgaon Tank Bunder dated 31.07.2023 as attached image for your reference.
- 2) Share submitted documents by Shri. Aziz ismail Dhariwal & others to obtain NOC mention in Point 1
- 3) Share order passed, answer or evert given, work done, remark given, site visit reports, Investigation reports, verbal as well as non verbal communication for written complaint given by Shri. Kiran shankar takle on 18/10/23 at Vijaydeep office mumbai to the estate manager.
Complaint copy attached for your reference.

3. AND WHEREAS, The Central Public Information Officer of the Estate Division of Mumbai Port Authority replied on 13.12.2023 to the RTI applicant as under:

As Regard No. 1 - 2 no. (2 pages) Letter dated 31.07.223 will be made available to you.

As Regard No. 2 - 4 no. (4 pages) will be made available to you.

As regard No. 1 & 2, total 6 pages will be available to you after paying the charges to MbPA amounting to Rs.12/- (Rupees Twelve only) [6 (Six) nos. of pages x Rs.2/- (Two) per page] and after producing the payment receipt in this office. The MbPA is accepting charges by Demand Draft/Postal Order only in favour of "The Board of Mumbai Port Authority" payable at Cash Office of the Financial Adviser and Chief Accounts Officer, MbPA, Port Bhavan, Ground Floor, S.V. Road, Ballard Estate, Mumbai 400 001.

As Regard No.3) - As per RTI guidelines the information sought should be specific. Hence, information cannot be furnished as it is not specific.

4. **AND WHEREAS**, Shri Kiran Takle, has preferred an Appeal dated 14.12.2023 received in this office on 19.12.2023. The said appeal interalia states as under:
- 1) information seek under RTI act in said RTI application Point no.3 information refused without giving proper justification
 - 2) Applicants wants to know status of complaint mention in said application and information requested is very specific related to this complaint only.
 - 3) Any documents mentioning progress or result of complaint mention in RTI application is requested by applicant. For examples investigation reports, progress, site visit reports, inter department communications etc.
 - 4) Applicant is ready to pay charges as per RTI act norm for electronic as well as paper data.

The ground for Appeal is refused access to information requested.

5. **AND WHEREAS**, the undersigned has gone through the RTI application dated 01.12.2023 and the reply dated 13.12.2023 by CPIO of Estate Division and points made in Appeal as well as the comments of CPIO, Estate Division thereon.

At the outset it is observed in RTI application dated 01.12.2023 & Appeal dated 14.12.2023 that the information sought is not specific such as verbal as well as non verbal communication for written complaint dated 18.10.2023, Any documents mentioning progress or result of complaint mention in RTI application.

Further, as per RTI guidelines the information sought should be specific. Hence, information cannot be furnished as it is not specific.

6. **NOW, THEREFORE**, based on the above observations the Appeal is rejected and disposed off.


7. If Shri Kiran Takle is aggrieved by this order, he may prefer Second Appeal to the Central Information Commissioner together inter-alia with the following documents:

- i) Self attested copies of the Orders or documents against which the appeal is being preferred.


