As per the Order referred above, Govt. of Maharashtra is pleased to impose fishing ban on Motorized & Mechanized fishing vessels in the territorial waters of Maharashtra from 1 June 2024 to 31 July 2024 (both days inclusive) for conservation and effective management of fishery resources and also for safety reasons.

Besides this, the Government of India, Ministry of Fisheries, Animal Husbandry, Dairying (Department of Fisheries) order dated 22/02/2024 has informed that the President of India is pleased to impose a uniform ban on fishing vessels in the Indian Exclusive Economic Zone (EEZ) beyond territorial waters on the East Coast (including West Bengal, Odisha, Andhra Pradesh, Puducherry, Tamil Nadu, Andaman & Nicobar Islands) and West Coast (including Gujarat, Daman & Diu, Karnataka, Goa, Maharashtra, Kerala, Tamil Nadu, and Lakshadweep Islands) as per period mentioned below for conservation and effective management of fishery resources and also for sea safety reasons.

**For the East Coast- from 15/04/2024 to 14/06/2024 (both days inclusive-61 days)**

**For the West Coast- from 01/06/2024 to 31/07/2024 (both days inclusive-61 days)**

The traditional non-motorized fishing vessels shall be exempted from this uniform fishing ban imposed in territorial waters and in the Indian EEZ area.


The President of India is pleased to impose a uniform ban on fishing by all fishing vessels in the Indian Exclusive Economic Zone (EEZ) beyond territorial waters on the East Coast [including West Bengal, Odisha, Andhra Pradesh, Puducherry, Tamil Nadu, Andaman, & Nicobar Islands] and West Coast [including Gujarat, Daman & Diu, Karnataka, Goa, Maharashtra, Kerala, Tamil Nadu and Lakshadweep Islands] as per period mentioned below for conservation and effective management of fishery resources and also for sea safety reasons:

East Coast-from 15<sup>th</sup> April to 14<sup>th</sup> June 2024 (both days inclusive) (61 days)

West Coast-from 1<sup>st</sup> June to 31<sup>st</sup> July 2024 (both days inclusive) (61 days)

The traditional non-motorized units shall be exempted from this uniform fishing ban imposed in the Indian EEZ beyond territorial waters.
