Income Tax Authorities have issued certificates u/s.197 of Income Tax Act, 1961 r.w.s.194A, 194C,194 IB and 194J ibid authorizing Port users lessees & tenants and banks / financial institutions with TAN mentioned in the certificates to deduct tax at source at lower rate as mentioned below:

Details are as under:

2. The certificates are valid for the period from <u>08/07/2024 to 31/03/2025</u>. The certificates are conditional and the lower rate of TDS is applicable on the quantum of income mentioned in col. 7 of the certificate. Thus, the parties whose names with TAN appear in the certificates have been authorized to deduct the tax at reduced rate allowed of I. T. Act, 1961.
