Sub: Rationalization of Tariff for Cruise Vessels

Ref : Circular No. TM/BDC/11-2/116 dated 14.08.2023

By Circular No. TM/B/11-2/16 dated 14.08.2023, it was informed that the ongoing rationalization of tariff for cruise vessels is extended from 01<sup>st</sup> October, 2023 upto 30<sup>th</sup> September, 2024. That the extensions of further period will be reviewed, if required.

2. Now the Ministry of Ports, Shipping & Waterways by letter no. SW-15011/2/2020-MG dated 24<sup>th</sup> July, 2024 has informed as under :

- i. Cruise Tariff for a cruise ship shall be recovered @ \$ 0.085 per GRT (fixed rate) and \$ 6 per passenger (Head Tax) for the first 12 hours of stay.
- ii. Fixed charge of \$ 0.0175 per GRT per hour on Cruise Ships for the period beyond 12 hours of stay of cruise ship at berth shall be levied.
- iii. Volume Discounts to Cruise ships shall be given as under:

Upto 10 calls per year - No rebate,  
From 11 calls to 35 calls per year - 10% rebate,  
From 36 calls to 70 calls per year - 15 % rebate,  
Above 70 calls per year - 20% rebate.

3. The above instruction will be effective for 1 year, i.e. from 01.10.2024 to 30.09.2025.

Sub: Rationalization of Tariff for Cruise Vessels

Ref: Circular No. TM/BDE/11-2/115 dated 14.08.2023

By Circular No. TM/BDE/11-2/115 dated 14.08.2023, it was informed that the existing recommendation of tariff for cruise vessels is extended from 30.09.2023 upto 30.09.2024. That the extensions of further period will be reviewed if required.

2. The Ministry of Ports, Shipping & Waterways by letter no. SW 15073-1/2023-24 dated 24.07.2024 has informed as under:

(i) For a cruise ship with an average of 2000 passengers and 200 crew members, the tariff for the first 10 hours of stay shall be fixed at \$ 0.0175 per GRT per hour for the period beyond 12 hours of stay as follows: (i) 15% rebate for the period of 12 hours to 24 hours; (ii) 15% rebate for the period of 24 hours to 36 hours; (iii) 15% rebate for the period of 36 hours to 48 hours; (iv) 15% rebate for the period of 48 hours to 60 hours.

Up to 10 calls per year - No rebate.  
From 11 calls to 20 calls per year - 10% rebate.  
From 21 calls to 30 calls per year - 15% rebate.  
Above 31 calls per year - 20% rebate.
