Issue of Unauthorized Transactions of Land / Properties Owned by

Mumbai Port Authority.

Mumbai Port Authority (MbPA) is holding 843 Hectares of land in Island City of Mumbai and 101 Hectares of land outside Mumbai City limits (Total 944 Ha). In 2018, the State Government of Maharashtra has declared, Mumbai Port Authority (erstwhile Mumbai Port Trust), as Special Planning Authority under Gazette Notification No. TPB-4317/492/CR-289/2017/UD-11 dated 23.04.2018.

A large no. of plots (at present around 267 Hectares) are historically letout to lessees/tenants on various tenures. In most of the cases the leases have expired and without the knowledge of MbPA, such lessees are entering into unlawful transactions. Large unauthorized encroachments are taking place on MbPA land. We have identified such cases and are in the process of lodging criminal offences against responsible persons & officials with Central Law Enforcement Agencies.

In order to restrict the MbPA lessees/tenants from entering into illegal/unlawful transactions, such as assignment, subletting, sale, change of user etc., it is requested to issue suitable instructions to your subordinate offices/concerned officials and all General Insurance Companies that, 'No Objection Certificate (NOC)' from Mumbai Port Authority shall be insisted upon before issuing new general insurance policy like fire, theft, natural and manmade disasters etc. (excluding health and life insurance policy), for applications having address on MbPA land and structures. Estate Manager is the nodal officer in MbPA for the same. All letters for NOC may kindly be addressed to —
