Dear Sirs,

Sub : Request of M/s. JSW Steel for berthing of their non-scheduled vessels at Mumbai Port/OCT berth for shipment of export cargo viz. HR Coils / CR Coils etc. after completion of maximum 03 days of waiting at most.

Ref. No. TM/B-1/26 dated 24.01.2024

In continuation to the above referred circular dated 24.01.2024, Exporter M/s. JSW Steel have informed Mumbai Port Authority that they have planned to export huge volume of Iron and Steel cargo viz. HR Coils/ CR Coils etc. for shipment through Mumbai Port immediately. They have informed that their endeavor is to increase the export volume from Mumbai port even more in the upcoming months and requested for support.

M/s. JSW have therefore requested Mumbai Port Authority for allotment of Mumbai Port / OCT Berth for their export vessels after completion of maximum 03 days of waiting at most.



2. Presently, as per the existing practice the agent should submit the application for berth atleast 07 days prior to ETA. Confirmed ETA may be given 03 days prior to actual ETA. Thus, such non-scheduled Export /Import deep drafted over dimensional vessel, if require BPS/BPX/Harbour Wall/OCT berth, has to wait for berthing until it completes 07 days scheduled criteria. Also, Non-scheduled vessels after completion of 7 days are allotted berths after reckoning them in common seniority alongwith other priority /non priority, Import/Export deep drafted over dimension vessel, vessels which have been already declared by vessel agents for allotment of suitable berths well in advance on the principle of common seniority and on first cum first basis.

3. In view of the above and in order to attract and retain cargo at MbPA, the Competent Authority has accorded approval to the request of M/s. JSW Steel being a major exporter for reinstatement of facility of allotment of MbPA /OCT berth to their export vessels after completion of maximum of 3 days from the date of berthing application instead of present 07 days, on principle of first cum first basis and as per common seniority and as per the prevailing criteria of prevailing Berthing Policy **for a period of six months from 27.09.2024**, subject to minimum 60% export cargo should be available on hand and export documents should be ready before allotment of berth to the vessel for loading.

4. You are requested to give wide publicity of above facility given to M/s. JSW Steel amongst all your members to avail the benefits of the aforesaid facility.
