Digitally signed and uploaded, Online bids under Single stage Two Cover system are invited by the Chief Engineer on behalf of the Board of Mumbai Port Authority from experienced, resourceful firms with proven technical and financial capabilities as detailed in RFP-Request for Proposal (bid) document for the following project.

The tender sets will be available for download till due date on [www.eprocure.gov.in](http://www.eprocure.gov.in) and [www.mumbaiport.gov.in](http://www.mumbaiport.gov.in) as details in the tender notice.

3. The bid document carries non-refundable tender fee payable online at <https://eplatform.mbptedi.gov.in> as per the directions given in the Tender Notice. There will not be physical or manual sale of bid documents. The proposals should be submitted in accordance with the Instructions to Bidders related to e-tendering and Instruction to Bidders as enumerated in the bid documents.

4. The DD/Bank Guarantee for the Bid Security is to be submitted in Original till Due Date and time, in a sealed cover superscribed with the Tender No., Name of Work and Contact Details of the Bidder in the box provided at Office of the Chief Engineer, Mumbai Port Authority, Accounts Section, Vijay Deep, 4<sup>th</sup> Floor, SV Marg, Fort, Mumbai 400001. Copy of the DD/Bank Guarantee is to be submitted with the online Bid at [www.eprocure.gov.in](http://www.eprocure.gov.in) Contravention of the above procedure will lead to disqualification of the Bids. The offers of the bidders whose sealed cover as described above is not received till due date and time, even though posted in time will be considered as late bid and will not be accepted.

5. The Bank Guarantee for Bid Security is liable for encashment if the successful Bidder refuses the work awarded to them.

6. The downloading and submission of Bid Documents shall be carried out as mentioned at Instructions for Online Bid Submission in the Tender and instructions at e-Procurement website <https://eprocure.gov.in>. No editing, addition/ deletion of matter shall be permitted.

7. Pre bid replies/addendum/ amendments/ errata if any etc. will be made available at the e-procurement website <https://eprocure.gov.in/eprocure/app> and Bidders are requested to check and download the same for submission. This website can also be accessed by clicking the link at MbPA's Website <http://www.mumbaiport.gov.in>.

8. The bidder has to submit his offer online at the e-procurement website <https://eprocure.gov.in> using valid Digital Signature Certificates. As tender submission is online on CPP portal, the payment of Tender Fee now to be made online. Tenderer shall visit <https://eplatform.mbptedi.gov.in> for making the payment for Tender Fee and choose the option "**Latest Tenders**" on the dashboard. After selecting the relevant tender, the tenderer can make online payment after entering the basic details of bank for refund purpose, the receipt generated as PDF file of Tender Fee shall be uploaded by the tenderer on CPP Portal under relevant option as a proof for the payment, failing which Tender will not be opened. The details of bank payment reference number and payment date also need to be entered while uploading in the relevant fields. It is mandatory to submit hard copy of the online receipt alongwith other required documents. Since the Tender set is non-transferable, the tenderer who is making the online payment should only utilize the same for submitting his/her own Tender on CPP portal.

9. The cost of tender set and Bank Guarantee for Bid Security will be accepted in the manner specified in the Bid document.

10. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions are given in the Bid document to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. 11. Online Technical Proposal (First Cover) uploaded at <https://eprocure.gov.in/eprocure/app> will be opened as per schedule mentioned above. Bids of the Bidders will not be opened in case the Bid Security and Tender fee is not submitted in the form and manner described above.

12. The bids shall remain valid for a period not less than 180 days from the Bid Due date

13. Commercial proposal- The bidder shall submit his offer in Commercial proposal online in the Excel format provided in Bid documents and no other format is acceptable. Bidders are requested to quote their Price for the subject work in the Excel file (.xls) published along with this tender. Price bid should not be submitted in hard copy format in any case.

**Note :** Bidder is responsible to download Bid document and Addendums/ Amendments/ Errata/ Replies to the queries of the Bidders etc., if any, issued by MbPA, from the website before submission of the Tender. Any shortfall in submission of the said Addendums/ Amendments / Errata/ Replies to the queries of the Bidders etc. along with the downloaded documents while submitting the Tender then such offer may not be considered.
