Mumbai Port Authority (hereinafter referred as Tender Inviting Authority and also called the Tender Acceptance Authority unless the context otherwise requires) invites online Tenders under Single Stage Two Cover system by the Chief Medical Officer I/c on behalf of Trustees of the Port of Mumbai (also referred to as Mumbai Port Authority) from experienced, resourceful firms with proven technical and financial capabilities for outsourcing of Ambulance services by supply of- (i) 4 nos. Basic Life Support Ambulances, (inclusive of 2 BLS ambulance for Port Fire Services) (ii) 1 no. Advance Life Support (Cardiac) Ambulance at Mumbai Port Authority Hospital, Wadala-400037 initially for a period of one year, further renewable for one year based on satisfactory work performance or till handing over of the hospital to the Concessionaire, whichever is earlier for the 2 BLS& 1 ALS ambulances earmarked for hospital and extendable for a period of 1 year on the same terms, conditions and rates at the option of MbPA if required. In case of 2 Nos. BLS ambulances utilized for Port Fire Services, the monthly billing payment, will be settled by Port Fire Service, Mumbai Port Authority. However, 2 BLS &1 ALS ambulances services of Medical Department will be continued till handing over of the hospital to the Concessionaire (extendable for further period of one year on same terms, conditions and rates at the option of MbPA if required).

MbPA now invites the interested bidders ("Bidders") meeting the Minimum Eligibility Criteria to participate in the Bidding Process. Mumbai Port Authority seeks to qualify and select a Bidder/s for outsourcing of Ambulance services by supply of- (i) 4 nos. Basic Life Support Ambulances, (inclusive of 2 BLS ambulance for Port Fire Services,

Mumbai Port Authority) (ii) 1 no. Advance Life Support (Cardiac) Ambulance at Mumbai Port Authority Hospital, Wadala-400037 initially for a period of one year, further renewable for one year based on satisfactory work performance or till handing over of the hospital to the Concessionaire, whichever is earlier for the 2 BLS & 1 ALS ambulances earmarked for hospital and extendable for a period of 1 year on the same terms, conditions and rates at the option of MbPA if required. Through single stage two cover systems based competitive bidding process. All bids i.e. technical bid and price bid will be prepared and submitted in accordance with such terms on or before the date mentioned under the Bidding Process and Schedule contained herein ("Bid Due Date").

- 2. Bidders are requested to note that the Tender will be initially for a period of one year, further renewable for one year based on satisfactory work performance or till handing over the hospital to the Concessionaire; and further extendable for a period of one year again based on satisfactory work performance on the same terms, conditions and rates at the option of MbPA or till handing over the hospital to the Concessionaire, whichever is earlier.
- 3. The Tenderers are instructed to Bid the Price Bid separately for BLS Ambulance or ALS Ambulance as per Annexure VII a and Annexure VII b respectively. The allotment of contract will be issued to the Bidder qualifying all the terms and conditions set out in this Tender and quoting the lowest rate separately for BLS Ambulance and separately for ALS Ambulance as to provide (i) 4 nos. Basic Life Support Ambulances, (inclusive of 2 BLS ambulance for Port Fire Services, Mumbai Port Authority) & (ii) 1 no. Advance Life Support (Cardiac) Ambulance at Mumbai Port Authority Hospital, in its second e-tender cover, i.e., Price Bid, shall be eligible for selection ("Selected Bidder") by Mumbai Port Authority.
- 4. Bidders are requested to note that that price bids are to be submitted separately for providing BLS Ambulances and ALS ambulances as per Annexure VII a and Annexure VII b respectively. Please note that the price bids quoted for the two different items will be considered separately for financial grading and not cumulatively. While uploading the PDF BOQ, if the bidder is not quoting for any item, he should strike out /or write 'Not quoted' for the particular item.
- 5. The bidders who intend to avail benefits under the Public Procurement Policy (Preference to Make in India) under orders dated 15.06.2017 and 16.09.2020 read with other orders mentioned therein, are required to submit duly attested supporting documents in order to establish his claim. Non submission of any documents in support of the claim will lead to disqualification. (Please refer to Annexure XIV for Govt OM's)
- 6. The Contract (*as defined herein*)sets forth the detailed terms and conditions for the performance of Services of providing "(i) 4 nos. Basic Life Support Ambulances, (inclusive of 2 BLS ambulance for Port Fire Services, Mumbai Port Authority) (ii) 1 no. Advance Life Support (Cardiac) Ambulance at Mumbai Port Authority Hospital.

- 7. The statements and explanations contained in this Tender are intended to provide a better understanding to the Bidders about the subject matter of this Tender and should not be construed or interpreted as limiting in any way or manner the scope of services and obligations of the Selected Bidder as set forth in the Contractor MbPA's rights to amend, alter, change, supplement or clarify the scope under the Contract, to be awarded pursuant to this Tender or the terms thereof or herein contained. Consequently, any omissions, conflicts or contradictions in the Bidding Documents are to be noted, interpreted and applied appropriately to give effect to this intent, and no claims on that account will be entertained by Mumbai Port Authority.
- 8. Tender documents may be viewed or downloaded by interested and eligible Tenderers from the website https://eprocure.gov.in/eprocure/app the above mentioned dates after payment of Tender fee of Rs.1000/plus 5% GST (Total Rs.1050/). Payment of EMD fees also has to be done online. After selecting the latest tender, the tenderer can make online payment after entering the basic details of the bank.
