- 1. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the
- completed financial years after the date of constitution shall be taken into account for this criteria.

 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

a. Copy of PAN Card.

- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

3. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. Click here to view the file

4. Generic

Malicious Code Certificate:

The seller should upload following certificate in the bid:-

- (a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-
 - (i) Inhibit the desires and designed function of the equipment.
 - (ii) Cause physical damage to the user or equipment during the exploitation.
 - (iii) Tap information resident or transient in the equipment/network.

PRE QUALIFICATION CRITERIA (PQC)

- 1. Bidder should have Average financial turnover of minimum Rs.68 lakhs in last three fina ncial years (2020-21, 21-22, 22-23). This must be individual company turnover and not gro up of companies. In this regard, the bidders have to submit certification from Chartered Account ant/Cost Accountant.
- 2. The bidder must have experience of successfully executed/completed (any of three optio ns A,B,C) for supply of desktops over the last three years i.e. the current financial year and the last three financial years : -
 - A. Three similar completed services costing not less than the amount equal to Rs.91 lakh
 - B. Two similar completed services costing not less than the amount equal to Rs.114 lakh
 - C. One similar completed service costing not less than the amount equal to. Rs. 182 lakh

In this regard, the bidders have to submit Purchase/Contract order, Work Completion Certificate issued by the buyer and TDS certificate or form 26AS for proof payment.

- 3. Bidders will have to submit Bid Specific OEM Authorization Certificate which will be verified with the OEM. The bidders must provide details of OEM authorization details such as name, designation, email id, address and phone number.
- 4. Bidder should have Service office in MMRDA region. The firms have to submit valid documents for the same.

ADDITIONAL CONDITIONS

- 1. Bidder should not have blacklisted in any organization in PSU / State Govt / Central Govt / Banks / Research Institute in India under Ministry of Ports, Shipping and Waterways. Bidde r should submit self-declaration for this.
- 2. All the bidders have to furnish Integrity Pact along with the Bid. The format of integrity p act is given in the bid. The scanned copy of Integrity Pact Agreement signed by the bidder i s to be uploaded.

- 3. THE SUCCESFUL BIDDER HAS TO SUBMIT **5% OF TOTAL AMOUNT AS PERFORMANCE BAN K GUARANTEE (SECURITY DEPOSIT) VALID FOR A PERIOD 66 MONTHS i.e.** IT WILL B E RELEASED SIX MONTHS AFTER THE WARRANTY PERIOD IS OVER AFTER SUCCESSFUL EXE CUTION AND COMPLETION OF THE GEM CONTRACT IN FULL SATISFACTION OF MBPA. THE B IDDER SHOULD SUBMIT BANK GUARANTEE WITHIN 30 DAYS FROM THE DATE OF PURCHASE ORDER FAILING WHICH 0.5% PER WEEK LIQUIDITY DAMAGE CHARGES ON BANK GUARANTE E SHALL BE APPLICABLE.
- 4. The bidders have to provide the detailed specification of desktops along with catalogue of the offered product.
- 5. The power of attorney (duly notarised by public notary) is required in all cases except in case of proprietorship firm if the same is signed by proprietor himself. In case of company the Board resolution is also required in addition to the POA. Partnership firm should submit partnership deed. Power of attorney should be submitted on stamp paper.
- 6. Installation image to be prepared as per MbPA instructions and shall loaded on all deskto ps. Antivirus shall be provided by MbPA which shall be installed on all desktops. The approv all should be obtained from MBPA before installing image on all desktops.
- 7. The installation of the desktops shall be at various locations of MbPA.
- 8. MbPA users existing data from desktops/PCs should be migrated to new desktops by the successful bidder. The successful bidder has to make own arrangements for migration of da ta from old systems to new desktops.
- 9. The successful bidder has to enter into Non-Disclosure Agreement (NDA) with MbPA.

10. Liquidated Damages:

LD shall be applicable separately on supply of Goods and Installation. The successful bidder has to supply and install the desktops within the delivery period of 120 days failing which LD shall be applicable.

Any delay on account of MbPA shall be exempted from the period of installation with the ap proval of CME.

The successful bidder has to maintain the entire timeline of installation and submit the dail v report to MM Division.

LD on the installation shall be calculated on 25% of the quoted amount.

LD on the supply of desktops shall be calculated on 100% of the quoted amount.

11. Payment Terms:

- A) 70% payment shall be made against acceptance of the material,
- B) Remaining 25% shall be made after successful installation and commissioning of the des ktops and
- C) Balance 5% shall be released after successful completion of 5 years warranty period.

However, the successful bidder can submit 5% Bank guarantee valid for a period of 66 months for claiming the above 5% amount. This 5% bank guarantee can be clubbed with the bank guarantee mentioned at point no 3 above and submit a single bank guarantee.

- 12. Land Border clause is applicable as the per the OM F. No 6/18/2019-PPD dated 23.07.2020 of Ministry of Finance in term of Rule 144(xi) in the General Financial Rules (GFRs) 2017.
- 13. No queries shall be entertained other than representations made on GeM bid.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
