Mumbai Port Trust had awarded the above contracts to M/s. Jaisu Shipping Co. Pvt. Ltd. with the registered office at Kewalramani House" Dinshaw Building Road, Near F & C Building, Kandla Port, Gujarat – 370 210. The details of which are as under :

2. The contractor failed to fulfil the contractual obligation and abandoned the work. Considering the gravity of breach committed and their poor performance, the Board of Trustees of Mumbai Port Trust in the meeting held on 14.06.2013 as approved debarring M/s. Jaisu Shipping Co. Pvt. Ltd from participating in any future tenders of Mumbai Port Trust for the next 7 years w.e.f.14.06.2013. Furthermore the associate companies of M/s. Jaisu Shipping Co. Pvt. Ltd or a

company where the directors / shareholders of M/s. Jaisu Shipping Co Pvt. Ltd. are associated or Joint Venture or sister concern of M/s. Jaisu Shipping co.pvt. Ltd. have also been similarly debarred.
