Sub: Debarring from taking up any MbPT contracts
for a period of 3 years.

Ref: This office work order No.CE.T.74/2016/1545
dated 26.05.2016.

The Housekeeping work in MbPT estate under Tender No.CE.T.74/2016 ("Tender") was awarded to you vide above referred work order with a contract period of one year. However, the work was abandoned by you after carrying out housekeeping work only for 41 days.

2. You were informed and advised vide this office letters dated 29.06.2016, and 11.07.2016 to continue with the work and you were also intimated that discontinuation with the work under the Tender will amount to abandonment of the contract which will lead to carrying out the housekeeping work at your risk and cost.

3. Hence, you were given an opportunity and advised to continue with the work under the Tender and not to abandon the same.

4. Despite the aforesaid advice to you, you abandoned the housekeeping work thereby causing inconvenience and disruption of services to us. The housekeeping work for the balance period of the contract was carried out by engaging other agencies at your cost and risk.

5. Hence, you took a decision of abandoning the contract under the Tender on your own and subjected us to inconvenience and disruption of services.

- 6. Taking into consideration the inconvenience and disruption of services caused to us due to your failure to fulfil contractual obligations under the Tender, your firm is debarred from taking up any MbPT works for a period of 3 years from the date of issue of this letter.
- 7. This is without prejudice to any other rights and remedies that we have under the Tender and under applicable laws, which you may please note.
